2016 saw the results of the clinic relocation in 2015 with more patients being served at the central clinic location. Additional equipment installed in the clinic added to this increased capacity. The Ambassador Program, a patient education program, was also initiated. Additionally, mobile outreaches were started up the Nile River further adding to the scope of the operation.

4b (Code:) (Expenses \$ 14,406. including grants of \$) (Revenue \$ 16,009.) Hope Smiles Haiti

In 2016 Hope Smiles concluded a partnership with Mission Of Hope with the establishment of the Hope Smiles Dental Clinic in Titanyen, Haiti. A part time Haitian Dentist was hired to begin dental clinic operations. Additionally, a complete mobile dental clinic was equipped and operations developed to send short term mission trips to the 12 villages served by Mission of Hope.

2016 saw the expansion of the Domestic Outreach Clinics into the State of Texas with a one day clinic in Waco, Texas where over 250 patients were helped in one day. Two Outreaches are planned for 2017 in Austin, Texas. The Outreaches in Nashville were again successful treating over 1000 patients.
